* In conjunction with the revision of the Ministerial Order, starting from the fiscal year ended March 31, 2010, the results for "FTTH Access Services" will be disclosed. In addition, "Leased Circuit Services" has moved from "Specified Telecommunications Services" to "Designated Telecommunications Services other than Specified Telecommunications Services".
